FARM HOUSEHOLD ALLOWANCE

A payment for farming families in financial hardship who meet the income and assets test. From 1 July 2019, the farm assets test threshold increased permanently to \$5 million. This is to make Farm Household Allowance accessible to more farmers.

AUSKEY AND MANAGE ABN CONNECTIONS

From 1st April, 2020 the way you access government online services will change. Auskey and Manage ABN connections will be retired.

New digital services will transform the way Australians interact with the government. These services are:

- myGovID - www.mygovid.gov.au an authentication service that allows you to prove who you are online. It is different to myGov. You cannot access myGov using myGovID yet.
- Relationship Authorisation Manager (RAM) - <http://info.authorisationmanager.gov.au> an authorisation service that allows you to link your myGovID to an Australian business number (ABN) and manage who can act on behalf of your business/entity online.

In the lead up to 1st April, 2020, AUSkey and Manage ABN Connections will still be available.

We will provide further information relating to the changeover in the coming months.
