MYGOVID

As of 27 March, 2020, you can no longer use AUSKey or Manage ABN Connections to access the Business Portal.

To make the move today:

- Set up your myGovID - download the myGovID app from the App Store or Google Play and use your Australian identity documents to enrol.
- Log in to RAM using your myGovID and link your business.
- Optional: Authorise your employees and others in RAM to act on behalf of your business online.

Note: myGovID is different to your personal myGov account.

FUEL TAX CREDITS

The fuel tax credit rate remains the same from 3 February, 2020 to 3 August, 2020.

Off-road is 42.3 cents per litre and On-road is 16.5 cents per litre.

JOBKEEPER

If you are not already receiving the JobKeeper payment, you are still eligible from whichever month you can show a 30% downturn in turnover.

RURAL BUSINESS SUPPORT (RBS)

Delivering a Small Business Drought Program to assist small rural businesses in drought affected areas to understand their financial position, identify options and implement plans to improve their viability and build resilience for future droughts.

To be eligible for the Small Business Drought Program you must:

- Employ 19 or fewer people.
- Be experiencing financial hardship or imminent risk of financial hardship.
- Be located in a drought affected area.

EMPLOYERS

Please be advised due to the Single Touch Payroll (STP) changes this financial year, you will no longer issue PAYG Payment Summaries to your employees.

Please let your employees know that "PAYG Payment Summary" is now called an "Income Statement" and can only be accessed through a taxpayer's myGov account or through their tax agent.

Employers are required to lodge a **Single Touch Payroll finalisation declaration** through whichever program you currently use, so the Australian Taxation Office has the information they require for each employee.

If you are lodging your own STP Finalisation Declaration, please be sure to check the information in your program is correct and that your payroll information reconciles to your accounting reports prior to submitting this report, otherwise it could cause amendments later to your employees tax lodgements.
